



## 2025 Annual Meeting Elections

There are five (5) Board of Director position up for election this year. The term is three (3) years for incumbents **Christine Wood, Hugo Holguin, Luis Valle-Vega, and Kathy Cash** who have been nominated by the Nominating Committee for re-election. Incumbent **Donna Soroczak** has been nominated for one (1) year by the Nominating Committee for re-election. There are two (2) Associate Board of Director positions up for election this year. The term is one (1) year. Incumbents **Torah Phillips** and **Suzeth Chisolm** have been nominated by the Nominating Committee for re-election.

Nominations for this position may also be made by petition. The petition must be signed by no fewer than twenty eight (28) members who are eligible to vote. Each nominee for the position must submit a statement of qualifications and biographical data with the petition. To be effective, any nominations by petition must be accompanied by a signed certificate from the nominee or nominees stating that they are agreeable to nomination and will serve if elected to office. The signed petition, candidate's statement and certification of agreement must be received no later than April 15<sup>th</sup>, 2025, at 4pm PST.
